

## **Terms and Conditions**

- 1.** No exhibitor will be given the stall allotment confirmation letter and allowed to participate in the exhibition without paying the full amount in advance towards stall space booked.
- 2.** No refund of payment will be made for cancellation of the stall space booked by the exhibitor, No exclusion of competition will be accepted. Smoking, alcohol, drugs etc. strictly prohibited.
- 3.** The decision of the organizers will be final and binding on all concerned and in all matters relating to the exhibition. Any or all legal disputes will be strictly restricted to the jurisdiction of courts in Ernakulam, India.
- 4.** The Organizers will be at liberty to change the layout, dates, timings or venue of the exhibition owing to unavoidable circumstances or to cancel the exhibition for such reasons under advice to the exhibitors. Force Majeure is applicable. On contingencies beyond control, postponement/cancellation will entail in reorganization / refund respectively less expenses. Claims if allowed restricted to amount paid by the participant. However alteration of space will not impose any such greater liability on the exhibitor than that contracted by him.
- 5.** The organizers will not be held responsible by the exhibitor for any mistakes, omissions, loss or damage to property at the site or injury to personnel and visitors and are deemed indemnified from such claims by exhibitors.
- 6.** Any damage or loss caused by any part of the exhibition centre or to any goods belonging to the other exhibitors or stand contractors in the exhibition will be charged for by the organizers from the concerned exhibitor who shall make the payment for any such damage or loss forthwith to the organizers if and when called upon to do so. Third party stands not to be entered /photo filmed by exhibitors outside opening hours without concerned exhibitor's permission. The organizers have exclusive right for photo/filming the exhibition.
- 7.** In case of borrowed equipment, display of name of lending firm not permitted unless they are also exhibitors in which case an acknowledgment card can be displayed.
- 8.** Every exhibitor and all people, for whom he may be considered responsible in any way whatsoever must conduct himself in such a manner as shall not be objectionable to any other exhibitor or visitor or organizers or the landlord. Any person who does not comply with these requirements shall be liable, at the discretion of organizers, to be removed from the exhibition site and refused re-admission during the period of the exhibition. No legal right of participation can be enforced. Sale / business transaction at expo site should be subject to the rules and laws of the land. Insurance as required to be ensured by exhibitors.
- 9.** Moving out material brought in for participation must be against out-pass obtainable from the Hall directors on show of in-pass which should be obtained when such equipments are brought in No exemptions are valid unless given in writing by the organizer. What is given is a license to exhibit only and not a tenancy.
- 10.** An exhibitor must conduct his business only from his stand and must not under any circumstances canvas amongst exhibitors in the exhibition. All efforts to advertise, promote sales and operate exhibits must be conducted so as not to cause annoyance or inconvenience to other exhibitors and visitors. Solicitations (in person or by any sound process) above the ordinary speaking tone of voice are prohibited without the written consent of the organizers. Political/ideological/competitive/superlative messages prohibited.
- 11.** An exhibitor shall not encroach on the aisles in front of his stand or any exhibition open areas or lobby and shall ensure that they are kept free from obstruction and any advertising all the time.
- 12.** Such exhibitors may be admitted additionally as agents only if mentioned so in original application. Prizes at the exhibition if any will be decided by an independent jury/s specially appointed by the organizers for this purpose and their decisions shall be conclusive, final and binding on all.
- 13.** All exhibitors will abide by the rules and regulations laid down by the organizers from time to time either verbally or in writing. The decision of organizers will be final on all matters.
- 14.** All exhibitors are deemed to have read, understood and agreed totally with all the terms and conditions mentioned above before signing the stall registration form.
